IN THE FINAL YEARS OF THE PARTNERSHIP, DZI COMMUNITIES ARE MORE UNIFIED, EARNING MORE INCOME, AND LEADING SAFER, MORE PRODUCTIVE, AND MORE CONNECTED LIVES. COMMUNITIES HAVE THE SKILLS AND SYSTEMS IN PLACE TO LEAD AND MAINTAIN THESE GAINS FOR A LASTING IMPACT.

OVER THE PAST 25 YEARS, DZI HAS GROWN TO SERVE MORE THAN 44,000 PEOPLE IN AN EXPANDING NETWORK OF RURAL VILLAGES IN THE SOLUKHUMBU, KHOTANG, AND BHOJPUR DISTRICTS OF EASTERN NEPAL.
